This project seeks to strengthen business integrity by fostering collective action to develop and improve anti-corruption policies, legal frameworks and other measures applicable to the private sector, and by building knowledge and capacity to enhance business integrity in accordance with the United Nations Convention against Corruption (UNCAC) and the Tenth Principle of the United Nations Global Compact.

Convened the first-ever Private Sector Forum at a CoSP in December 2023, bringing together over **200** stakeholders to discuss the future of business integrity



Over **500** companies signed an anti-corruption Call-to-Action urging governments to engage in collective action to tackle corruption effectively



Adoption of resolution 10/12 on "Providing incentives for the private sector to adopt integrity measures to prevent and combat corruption" by **190** parties at CoSP10
