## **What is the Private Sector Forum at COSP11?**

The Private Sector Forum at COSP11 is the primary gathering for companies to discuss their role in fulfilling their commitments to the [United Nations Convention against Corruption](#) (UNCAC) and [Principle Ten](#) of the UN Global Compact. It is held by the United Nations Office on Drugs and Crime ([UNODC](#)) and the [United Nations Global Compact](#), in collaboration with a number of partners.

The Private Sector Forum at COSP11 is also a place for companies to discuss common challenges, trends, innovative solutions and priorities in the field of governance and anti-corruption with private sector peers, via interactive sessions that also feature representatives from the public sector, civil society, academia and international organizations, as well as youth representatives.

In alignment with the overarching theme of COSP11, the Private Sector Forum agenda will place special emphasis on exploring the transformative role of artificial intelligence in strengthening anti-corruption efforts and addressing emerging integrity challenges.

## **What is COSP11?**

The eleventh session of the Conference of the States Parties ([COSP11](#)) to the United Nations Convention against Corruption will take place from 15 to 19 December 2025 in Doha, Qatar.

As the Convention's main policymaking body, the Conference of the States Parties convenes every two years to bring together States Parties, signatories, observer states, intergovernmental organizations, civil society, and leading experts in the field of anti-corruption. These sessions provide a strategic platform to assess progress in implementing the Convention, approach obstacles to integrity, and adopt resolutions that shape global anti-corruption priorities.

## **When and where is the Private Sector Forum at COSP11 held?**

The Private Sector Forum at COSP11 will be held in-person at the Sheraton Grand Doha Resort and Convention Hotel on 15 and 16 December 2025 in Doha, Qatar, on the margins of the eleventh session of the Conference of the States Parties (COSP11) to the United Nations Convention against Corruption.

## **Who should attend the Private Sector Forum at COSP11?**

Participation in the Private Sector Forum will be of interest to business leaders such as CEOs, chief compliance and chief legal officers, as well as other personnel dealing

with sustainability, business integrity issues and government relations. Representatives from the public sector, civil society, academia and international organizations engaging in this field are also welcome to attend.

### **What can you expect from the Private Sector Forum at COSP11?**

The Private Sector Forum at COSP11 will bring together business leaders, government representatives, civil society, academia, youth and international organizations to explore how artificial intelligence and emerging technologies can transform anti-corruption efforts while addressing critical ethical challenges. Through interactive sessions, multi-stakeholder discussions, and networking opportunities, participants will exchange concrete, innovative solutions for strengthening business integrity. This collaborative format fosters the co-creation of strategies that not only address corruption risks but also contribute to shaping the global business integrity agenda.

### **How can I register for the Private Sector Forum at COSP11?**

Interested participants are invited to begin by submitting an [expression of interest form to attend the Private Sector Forum](#). This initial step is required for consideration and does not guarantee registration.

Once your expression of interest is received, the organizers will share further details on the next steps, including how to complete your registration and prepare for travel, such as visa arrangements for Qatar.

Online registration via the [INDICO platform](#) is **mandatory** to obtain a unique ID/code required for both the **visa application for Qatar and entry to the venue** of the Private Sector Forum at COSP11.

- **If you are not part of a COSP11 delegation and would like to attend the Private Sector Forum: you should register for a special events badge by latest 30 November.**

When you start the registration process in INDICO, please select "Special Event Participant" under the field "Representation type" and select "Special Event Speaker" under the field "Function / Role". Please use the same email address throughout the entire registration process (the email address at which you received this message). Save this email as a PDF and upload it as a supporting document in the registration process in INDICO when asked to upload a supporting document (instead of a Note Verbale/Official Letter).

- **If you are part of a COSP11 delegation:** Please follow your country or organization's registration process to be part of the delegation. Delegates and media representatives are invited to register in INDICO as soon as possible, **latest by 30 November.**
